Privacy Notice – Contact Form

I. General Information

How do we use your data?

Our Privacy Notice provides an explanation of the way we collect, use, share and protect your personal data. In case of any future changes to this Privacy Notice, we will publish information concerning such changes in a timely manner.

Your rights regarding your personal data

Under the Bulgarian legislation you may exercise the following rights, related to the data processed by FICOSOTA Ltd:

- to access your personal data, which FICOSOTA Ltd processes and receive a copy thereof;
- your personal data to be rectified in case of inaccuracy or incompleteness;
- to request your data to be erased when there are prerequisites therefor;
- in the cases laid down by law to request restriction of your personal data processing;
- in the cases laid down by law to object to your personal data processing;
- to exercise your right to data portability and to request their provision to you in a structured, commonly used and machine-readable format;
- where processing is based on your consent, to withdraw your consent at all times, without having to pay any fees
- to file a complaint to the Personal Data Protection Commission

What is the legal basis for your personal data collection?
